## 2.3 Additional Information:

### a) Grading System:

Students are graded on a 0 to 20 point scale (minimum passing grade is 10) and according to the ECTS Grading Scale. The ECTS grading scale provides additional information on the rank of a student in a given assessment, i.e., how he/she performed comparatively to other students in the same class (or in a significant group of students). The grades are expressed as follows:

Local Grade	Definition
18 - 20	Excellent
16 - 17	Very good
14 - 15	Good
10 - 13	Sufficient
0 - 9	Fail

ECTS Grade	% of students who have achieved this grade	Definition
A	10	Excellent: outstanding performance with only minor errors.
B	25	Very Good: above average standard but with some errors.
C	30	Good: generally sound work with a number of notable errors.
D	25	Satisfactory: fair but with significant shortcomings
E	10	Sufficient: performance meets the minimum criteria.
F	---	FAIL - some more work required before the credit can be awarded.
